# REQUEST FOR PROPOSAL APRIL 2015 THE CITY OF FORT DODGE GENERAL NUISANCE & GRASS MOWING

- 1. The contractor shall use suitable equipment for mowing and removal of debris and appliances such as freezers, washers, dryers, dishwashers, refrigerators, hot water heaters, television sets, and microwaves.

  Debris and appliances will be removed and properly disposed.
- 2. All grass clippings will be removed from sidewalks and curb areas on the street. No piles of clippings or debris may be left in the yard. Hand equipment may be required for areas inaccessible with other equipment. The cutting height will be 3 inches. Clean up will be completed within 24 48 hours after notification of work.
- 3. Payments will be made during the City's regular payment schedule which is twice monthly. You will submit a bill to the Mayor's office no later than a week after completion with copies of landfill charges, junkyard charges, etc. Each bill turned in will need to be itemized by a square footage price per yard, equipment used, and any other miscellaneous charges.
- 4. The Contractor must present evidence of a comprehensive general liability insurance policy in the amount of \$1,000,000 covering claims of bodily injury or property damage. The City of Fort Dodge is to be named additional insured and shall be held harmless and indemnify the City from all claims arising from this contract. Proof of insurance will be necessary before work can begin.
- 5. The contractor must have a digital camera with the dates and times printed on each photo taken before and after the work is completed, photos need to be taken of the same location. For pictures of grass over 10" the height of the grass must be shown before and after with a measuring device that can be depicted in the photos. Failure to comply with the terms listed in this RFP will result in nonpayment for the job.
- 6. New jobs will not be issued until all billing information is turned in for previous jobs assigned to that contractor.

- 7. The City will retain the right to be the sole judge of quality and performance of the services rendered by the contractor. It is the City's intent to utilize one contractor under this contract for a period of 1 year however; the City reserves the right to use additional contractors to meet workload demands. The City reserves the right to bid "unique" jobs before awarding. Should the City determine the contractor is performing at an unsatisfactory level; the contract may be terminated with a written notice from the City.
- 8. Supply a list of 3 professional references.
- 9. Sealed written proposals for general nuisances and grass mowing within the city limits will be received by 3:00 PM on Thursday, April 2, 2015 at City Hall in the Mayor's Office, to the attention of the City Manager. Staff will evaluate the proposals and forward recommendations to City Council for award on April 13, 2015.
- 10. The City reserves the right to reject any or all bids, waive technicalities and award contract it deems in its best interest.
