The year 2019 was highlighted by continued partnerships throughout the county and region, as both public and private sectors showed continued economic growth and improvements to the quality of life we all enjoy. We all need to thank local and county governments, educational entities, and all the members of the Greater Fort Dodge Growth Alliance for their leadership, collaboration, cooperation, and ideas that have led to continued economic growth.

The housing partnership between the Growth Alliance, the City of Fort Dodge, and the Fort Dodge Betterment Foundation continued to show new housing starts, new private development as well as housing in Gowrie and other locations in Webster County.

The primary sector business continued to reinvest such as Nestle Purina, White Transfer and Storage and AML Riverside, among others. Some of the larger economic impact in the near future will come from the 2019 startup of Prestage Foods of Iowa in Wright County. The Prestage plant will provide large regional economic multipliers throughout all sectors of our economy.

The Webster County Board of Supervisors sold land to Cargill in Iowa's Crossroads of Global Innovation and further continued improve the economic competitiveness of the park.

The Growth Alliance client list is as large as it has ever been, quality of life and workforce initiatives are continuing to improve, and we expect 2020 to significantly exceed the progress made in 2018 and 2019.

ECONOMIC DEVELOPMENT

Fort Dodge Turns 150

2019 marked the City of Fort Dodge's 150th anniversary of the city's charter. The community celebrated by creating a logo that was used on promotional pieces and to identify events related to the anniversary. The most iconic remembrance of Fort Dodge's 150th celebration was the commission of "The Chronicle", a 22 foot sculpture which represents history and elements of our community.

The community of Fort Dodge traces its origins to the U.S. Army's establishment of Fort Clark in 1850. The military post was set up and occupied by the troops of Company E of the 6th Infantry. There were two officers and 66 enlisted men in the unit. In 1851, the post's name was changed to Fort Dodge. The Army shut down the fort in June 1853 and the soldiers were sent to an outpost in Minnesota. William Williams, who was a civilian merchant at the fort, then led the development of a city at the site of the military post. The community of Fort Dodge got its start in the second half of 1853, but wasn't formally chartered until 1869.





MidAmerican Energy Service Center Investment

In early 2019, MidAmerican Energy cut the ribbon on their new 72,000 square foot service center in the Decker Development Park. The facility services over 32,000 customers in North Central lowa. The building was constructed to create an environmentally friendly place to work and a contemporary design for the efficiency of their employees. MidAmerican Energy is an important partner in economic development by providing over 50% of their energy is renewable. They also financially support the Growth Alliance efforts through their community partnering program.





White Transfer and Storage Expansion

In the fall of 2019, White Transfer and Storage Company invested \$2 Million in a 500,000 square foot warehouse project in Webster County, west of Fort Dodge. This is the second expansion White Transfer had made in the last two years. The expansion will service existing businesses in the region for both outgoing and incoming finished and raw materials.



Iowa Central Community College Expansion

lowa Central Community College started construction on the Greehey Family Student Success Center. The new center will consolidate veterans services, enrollment services, student advising, financial aid, the registrar, counseling, housing, career services, distance learning, early intervention support



and security in one place. The new center is being paid in part by a generous donation from the family of Bill Greehey, a Fort Dodge Senior High School graduate who was the chairman of Valero Energy Corp. He donated \$3 million for the facility. The remaining costs will be covered by the \$25.5 M general obligation bond the college received in 2018.

CATALYST TO RETAIL REDEVELOPMENT

As a retail hub for Northcentral Iowa, Fort Dodge saw an opportunity with the sale of the empty Sears building. In the fall of 2019, within days, the 63,340 square foot building was demolished and removed from the 6.25 acre site making way for new development. The sale and removal of the Sears building gave way for the redeveloper to negotiate for the rest of the Crossroads Mall.



TOP 10 STATE AND COUNTY ECONOMIC SECTORS











GRP WITHIN THE MANUFACTURING SECTOR

Within Webster County's Manufacturing GRP, Biological Products make up 42% of the manufacturing sector, with Ethyl Alcohol (Ethanol) and Gypsum to follow. Interestingly, Gypsum production in Webster County makes up 67% of the entire state's manufacturing sector, our metal can sector 48% and biological 33%.




SURVEY SAYS...


FUNDAMENTALS
