WAIVER OF SEPARATION REQUIREMENT:

HUNT PROPERTY INFORMATION:

Per Iowa code 481A.123 Prohibited hunting near buildings, feedlots. 1. A person shall not discharge a firearm or shoot or attempt to shoot a game or fur-bearing animal within two hundred yards of a building inhabited by people or domestic livestock or within two hundred yards of a feedlot unless the **owner or tenant has given consent**.

This form shall be submitted to the City as evidence of a property owner's waiver of the 200-foot separation requirement. The waiver applies only to the property described in this waiver; only to the property owned by the person granting the waiver; and is subject to any and all conditions or limitations listed in this waiver.
