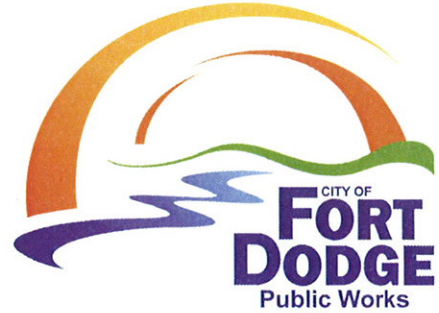

**Brief History**

Public Works received bids on April 2, 2015 at 10:00 A.M. for the purchase of two new trucks to be used by the Public Works Street Division. The trucks will be used for normal operations. Funds have been appropriated in the FY 14/15 Road-Use-Tax Capital Equipment budget for the purchase of these trucks.

**Analysis of Issue**

Public Works Street Division has twelve multi-purpose large trucks of which eight vehicles have been in service for 15-20 years, two have been in service 10-14 years, and two have been in service for three years. It is necessary to update the fleets in order to maintain the streets during the winter season, and maintain normal operations. Dump bodies and auxiliary equipment for the vehicles will be purchased separately. Requests for bids were sent to four suppliers. Fort Dodge Ford Lincoln Mercury submitted the only bid. Two vehicles will be traded in.


