

NOTICE TO BIDDERS
JURISDICTION OF CITY OF FORT DODGE PUBLIC IMPROVEMENT PROJECT

Notice is hereby given that a public hearing will be held by the *City of Fort Dodge* on the proposed contract documents (plans, specifications, and form of contract) and estimated cost for the improvement at its meeting at *6:00 P.M.* on *Monday, February 26, 2024*, in said **Fort Dodge City Hall at 819 1st Avenue South, Fort Dodge, Iowa**, Participation in this meeting will be available to be joined by webinar as listed on the City of Fort Dodge website at www.fortdodgeiowa.org.

Sealed bids for the work comprising each improvement as stated below must be filed before *2:00 P.M.* on *February 20, 2024*, in the office of the **City Clerk of City of Fort Dodge, Iowa**. Bids received after the deadline for submission of bids as stated herein shall not be considered and shall be returned to the late bidder unopened.

Sealed proposals will be opened and bids tabulated at *2:00 P.M.* on *February 20, 2024*, in the **Fort Dodge Council Chambers** for consideration by the **City of Fort Dodge** at its meeting on *February 26, 2024*.

Contract Documents

Preference of Products and Labor

By virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes.

In accordance with Iowa statutes, a resident bidder shall be allowed a preference as against a nonresident bidder from a state or foreign country if that state or foreign country gives or requires any preference to bidders from that state or foreign country, including but not limited to any preference to bidders, the imposition of any type of labor force preference, or any other form of preferential treatment to bidders or laborers from that state or foreign country. The preference allowed shall be equal to the preference given or required by the state or foreign country in which the nonresident bidder is a resident. In the instance of a resident labor force preference, a nonresident bidder shall apply the same resident labor force preference to a public improvement in this state as would be required in the construction of a public improvement by the state or foreign country in which the nonresident bidder is a resident.

General Nature of the Public Improvement

SOUTH DOWNTOWN DRAINAGE IMPROVEMENTS, PHASE II

The **SOUTH DOWNTOWN DRAINAGE IMPROVEMENTS, PHASE II** is located on S. 10th Street, south of 3rd Ave S to S 12th Street to 2nd Ave S and S. 12th Street from north of 1st Ave S to Central Avenue and Central Avenues west of S. 12th Street to 13th Street. The project consists of approximately 379 Units of Clearing and Grubbing, 750 CY of various topsoil placement, 1499 CY of Class 10 Excavation, 8418 SY Subgrade Preparation (12"), 272 SY Special Backfill Subbase (6" Depth), 7906 SY 6" Modified Subbase, 315 LF Sanitary Sewer Service Stub Removal and Replacement (4" and 6" Dia) , 775 LF of Storm Sewer Trenched (12" – 18" Dia), 672 LF of Storm Sewer Trenched (24"-36" Dia), 1000 LF of 42" Dia Storm Sewer Trenched (Class III and Class IV); 1324 LF of Storm Sewer Removal; 2286 LF of 6" Subdrain, 350 LF of 8" PVC C900 8" water main; 131 LF of PVC C900 12" water main; 758 LF of 16" water main various pipe types; 13 Type K copper water services; necessary fitting, valves, hydrants and removals; 21 Manholes including Sanitary and special structures, 22 intakes including special structures; 42 structure removals; 2173 SY 9" PCC Pavement (C-4WRC-20 or C-4WR); 445 SY 7" PCC Pavement (C-4WRC-20 or C-4WR); 1768 SY of Milling and Asphalt Overlay; 2" 2558 SY of removal of sidewalks, brick sidewalks, and driveway; 2314 SY of PCC sidewalk, various thicknesses including colored concrete; HMA and PCC full depth Patching; traffic control; Traffic signal removal; street lighting including powdercoat painting; pavement marking and signage; stormwater pollution prevention; seeding; modular block retaining wall; 21 CY of combined concrete sidewalk and retaining wall with form liner; 116 SF of concrete steps with hand rail; and temporary pedestrian access measures; along with various other related items.

Bid Alternates for A or B Bidding of South Work Area paving alternates:

Alternate A includes approximately 2157 SY of 7" PCC Pavement (C-4WRC-20 or C-4WR), 2459 SY of 8" PCC Pavement (C-4WRC-20 or C-4WR), together with PCC and HMA Pavement Samples and Testing.

Alternate B includes approximately 84 CY of Class 10 Excavation, 2027 LF of 2.5' wide PCC Curb and Gutter (7" and 9" thickness, 1812 SY 7" Asphalt Pavement, 2200 SY 9" Asphalt Pavement together with PCC and HMA Pavement Samples and Testing.

Contractors are required to bid both Bid Alternates. The BASE plus CITY SELECTED ALTERNATE will be awarded.

Bid Security

Each bidder shall accompany its bid with bid security as defined in Iowa Code Section 26.8, as security that the successful bidder will enter into a contract for the work bid upon and will furnish after the award of contract a corporate surety bond, in a form acceptable to the Jurisdiction, for the faithful performance of the contract, in an amount equal to 100% of the amount of the contract. The bidder's security shall be in the amount fixed in the Instruction to Bidders and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States; or a bid bond on the form provided in the contract documents with corporate surety satisfactory to the Jurisdiction. The bid shall contain no condition except as provided in the specifications.

The **CITY OF FORT DODGE** reserves the right to defer acceptance of any bid for a period of sixty (60) calendar days after receipt of bids and no bid may be withdrawn during this period.

Performance, Payment and Maintenance Bond

Each successful bidder will be required to furnish a corporate surety bond in an amount equal to 100% of its contract price. Said bond shall be issued by a responsible surety approved by **CITY OF FORT DODGE** and shall guarantee the faithful performance of the contract and the terms and conditions therein contained and shall guarantee the prompt payment of all material and labor, and protect and save harmless **CITY OF FORT DODGE** from claims and damages of any kind caused by the operations of the contract and shall also guarantee the maintenance of the improvement caused by failures in materials and construction for a period of two years from and after acceptance of the contract.

Title VI Compliance

The **CITY OF FORT DODGE**, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42U.S.C. 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

Commencement of Work

Work on the improvement shall be commenced any time after the after a written Notice to Proceed is issued, as early as April 2, 2024, and no later than May 13, 2024, and shall be completed as stated below.

Completion of Work

Contractor shall fully complete the project in ***125 working days***. Engineer may consider suspending working days for work that has commenced prior to the late start date. Should the contractor fail to complete the work in this timeframe, liquidated damages of **One Thousand dollars (\$1,000.00)** per working day will be assessed for work not completed within the designated contract term.

Parcel 36 (Laufersweiler Funeral Home) S. 12th Street Access: Contractor shall fully complete work in this area within 15 non-consecutive working days where vehicular access is not available. Fully complete shall be defined as completion of roadway and driveway pavements for access from S. 12th Street. Should the contractor fail to complete the work in this timeframe, liquidated damages of **Five Hundred dollars (\$500.00)** per calendar day will be assessed for work not completed within the designated contract term.

The **CITY OF FORT DODGE** does hereby reserve the right to reject any or all bids, to waive informalities, and to enter into such contract, or contracts, as it shall deem to be in the best interest of the jurisdiction.

Alternate B includes approximately 84 CY of Class 10 Excavation, 2027 LF of 2.5' wide PCC Curb and Gutter (7" and 9" thickness, 1812 SY 7" Asphalt Pavement, 2200 SY 9" Asphalt Pavement together with PCC and HMA Pavement Samples and Testing.

Contractors are required to bid both Bid Alternates. The BASE plus CITY SELECTED ALTERNATE will be awarded.

At said hearing, the **City Council** will consider the proposed plans, specifications, form of contract and estimate of cost for said project, the same now being on file in the **Office of the City Clerk of the City of Fort Dodge, Iowa at City Hall**, reference to which is made for a more detailed and complete description of the proposed improvements, and at said time and place the said Council will also receive and consider any comments/objections to said plans, specifications and form of contract or to the estimated cost of said improvements made by any interested party.
