# **Brief History**

As part of Phase 2 of the East Region Storm Sewer Project, the light pole on the west side of Sparkle Car Wash, 319 South 25<sup>th</sup> Street, will need to be relocated in order to construct a new drive entrance into the property.

The property owner has solicited a bid from his electrical contractor to complete the work.

# **Budget Impact**

A bid in an amount not to exceed \$7,500 has been submitted by Ty Wyatt Electric LLC.

- 1) Manufacture (4) mounting brackets for new lights out of 2" IMC pipe, with a welded base plate to fasten to roof top, and a bracket to fasten to top side of skirting.
  - 2) Mount (4) 100 LED parking lot lights to new brackets
- 3) Core drill concert roof in order to power new light. All conduit will be ran on the roof skirting, on the back side, so it is not seen from ground.
  - 4) Run wiring for new light and have them controlled by the time clock.
- 5) Reseal roof areas that were penetrated for mounting and feeding new lights.
- 60 Remove old lights from existing pole that is being eliminated, and remove feed wire from there power source.
