### **Brief History**

Iowa Code section 12C.2 states: "The approval of a financial institution as a depository of public funds for a public body shall be by written resolution or order that shall be entered of record in the minutes of the approving board, and that shall distinctly name each depository approved, and specify the maximum amount that may be kept on deposit in each depository."

#### **Analysis of Issue**

Due to the recent funds received from the jurisdictional transfer of state road 926, the current resolution on file was reviewed by the City Treasurer and City Clerk/Finance Director. Our auditor concurred with the staff recommendation that changes to the depository list should be made to reflect higher depository limits with each institution.
