What is the overall <u>deductible</u>?	\$500 person/ \$1,000 family per calendar year.	Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. Well-child care, telehealth services, in- <u>network</u> preventive care, in- <u>network</u> office services, in- <u>network</u> independent labs, in- <u>network</u> prosthetic limbs, services subject to prescription drug <u>copayments</u> and in- <u>network</u> outpatient services for mental health/ substance abuse.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Does this plan provide Minimum Essential Coverage? Yes

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
